1.	The directors and shareholders should be local residents in view of the pervasiveness of radio broadcasting.	1
2.	All shareholders must comply with all the applicable regulatory requirements.	1

3.	The applicant should be required to provide supporting documents to ensure that it can maintain its service for at least 3 years.	1
4.	There is no information on regular source of funding to maintain the broadcast service in the long run.	1

6.	Shareholders should undertake not to interfere with editorial freedom of the station by an internal firewall mechanism. Otherwise, the shareholders, being prominent political figures, may turn the station into a political propaganda machine.	2
